- We were warmly welcomed to campus by Dr. Randy Parker, President of GTCC, and invited to tour two new campus libraries.
- Alan Unsworth presented "NC Community College Libraries & Accessbility"

- -In 2017, all the NC Community Colleges must be compliant with web accessibility standards. This means that all students, those with and without disabilities must have "equal access" to electronic resources and the "same experience" with those resources.
- -Alan shared the Web Content Accessibility Guidelines Checklist (WCAG 2.0) and Voluntary Product Accessibility Template (VPAT) with us.
- -The system office will require that all NC Community College libraries receive a VPAT from any vendor whose electronic resource has been purchased by a library.
- -NC LIVE is aware of the requirement and will work towards compliance with all products in 2017.
- -Section 508 is not relevant to us, these guidelines are for the federal government only.
- -Libraries can use the WAVE tool to enter their library URL and find accessibility errors.

- -Any errors that appear in red will need to be corrected.
- -It will be useful to test library quizzes and tutorials in a screen reader like JAWS to make sure they work properly.

- -Springshare are working on accessibility in LibGuides. Currently "books from the catalog" and widgets have issues with accessibility. Alan has shared tips for working around the issues in his LibGuide: http://library.surry.edu/accessibility
- -NCKnows chat service widget is not currently compliant but they are working towards accessibility.
- -SIRSI has some errors in the WAVE tool. Alan has informed John Wood about these html errors that need to be corrected.
- -All streaming videos must have Closed Captioning option or transcript option in 2017. Films on Demand is in compliance. There was discussion about whether this impacts physical DVDs and VHS tapes currently held in our library collections.
- -David Wright shared a resource that he learned about at the ALA conference: www.adasoutheast.org
- Robert Antill, Director Fayetteville Tech shared the presentation "Avoiding Copyright Violations in the Digital Age"


