#### **Old Business**

1. Treasurer/Treasurer-In-Training Job Descriptions- Leslie Queen

Rewritten Membership job description was presented, based on feedback at last board meeting. Motion to approve by Ali Norvell; second by Cheryl Ann Coyle. Passed by voice vote.

Rewritten Treasurer/Treasurer-in-Training job description was presented based on feedback at last board meeting. Joel Ferdon expressed support for on-the-job training. Alisha Webb requested clarification about start date of Treasurer-in-Training; positions run conference to

conference. Leslie asked if changes affect the by-laws. Joel and Paula Hopper agree that by-laws will need to be amended. Cheryl Ann reminded the Board that it must be announced to membership to be voted upon; she also noted that we can vote virtually via MemberPlanet. Jennifer Seagraves will write up the changes and voting information for the newsletter. Motion to approve by Samanatha O'Connor; second by Alisha. Passed by voice vote.

#### **New Business**

#### 2. NCCCS eBook Consortium- Alan Unsworth and Joel Ferdon

RBDigital has been bought by Overdrive and this will bring changes to subscribers. Alan and Joel have been in contact with Overdrive representatives to discuss options available to NC Community Colleges. They suggest forming a CC consortium sponsored by NCCCLA; this would allow the NCCCLA president to sign the contract. The proposal offers very favorable pricing to members (see handout) and the breakdown of 20% for hosting costs/80% for content is unusually competitive for libraries. A question and answer session is being set up and Joel will keep members up to date. Cheryl Ann would like to know what happens if a library drops out after initial enrollment. Do we lose their content? Do prices go up? Alan pointed out that a CC consortium would improve the availability of titles to our users due to the smaller user base. A committee will need to be put together for decision making purposes including whether to move forward and resource allocation. Retha Hall asked if the Directors have been notified yet - no, this is laying the foundation. Cheryl Ann supports the idea but would like a presentation put together that can be used for the Directors and collection development staff. Motion to approve by Cheryl Ann; second by Jennifer Seagraves. Passed by voice vote.

#### 3. Equity Sub-Committee Report- Elizabeth Baker and Brittany Champion

Elizabeth Baker noted that the document presented to the Board is still a work in progress though mostly complete. The committee has met five times. Brittany Champion reviewed the document for the Board. Jennifer thanked the committee representatives and complimented the work done. Support also from Joel, Cheryl Ann, Katy Hoffler, and Ali Norvell. Jennifer requested that committee representatives speak again at the September meeting to update Board on their progress.
