New Business

CCLA and New Directors (Staci Wilson, Rich Garafolo)

Staci and Rich approached the Board about the possibility of NCCCLA giving CCLA space Ron the website to share and post documents. Does this fit with the organizations bylaws? Angela Davis asked whether all CCLA members are NCCCLA members, Rich noted that this is not the case. Cheryl notes that we have a CCLA rep. for all districts, so we are already connected. She also asks whether the Board needs to recognize CCLA as a component of NCCCLA. Staci notes that that would require CCCLA members to also join NCCCLA. Angela points out that membership dues support the website, member planet, etc. How does CCLA fit into that? Joel would like to know whether CCLA priorities mesh with NCCLA, would those need to be approved by the Board? Cheryl notes that committee priorities are not managed through the Board. Alan Unsworth would like to make sure that CCLA is independent from the system office. Angela notes that we would need a formal proposal from CCLA and the a vote from the Board if some resources and processes are shared. Finally, Joel wonders if CCLINC could have a home

with NCCCLA.

Rich Garafolo spoke about new library directors – New Directors Institute. He would like to see more consistency in development, possibly creating a subgroup, and removing the expectation that the CCLA rep is solely responsible for all mentoring within a District. Alisha notes that New Director's Institute is what separates CCLA from NCCCLA. Alan suggests bringing CCLA into NCCLA; Samantha O'Connor supports; there is much overlap in goals.

Staci and Rich will go back to CCLA for further discussion.

Equity Committee Report (Brittany Champion, Elizabeth Baker)

Elizabeth proposed making Equity Committee a standing committee; this was well received by the Board. Leslie Queen states that the President may establish a committee, the Committee Chair attends Board meetings. The committee will need to create by-laws. Jennifer Seagraves motioned to convert the Equity Committee to a standing committee; the motion passed. Brittany notes that there will be a session at the annual conference based on Equity Committee work.

There are currently 46 attendees which means the Conference has met its break-even numbers. Members will be sent a reminder email blast about registration. There will be breakout sessions, vendor presentations, and drawings (based upon donation to scholarship funds).
