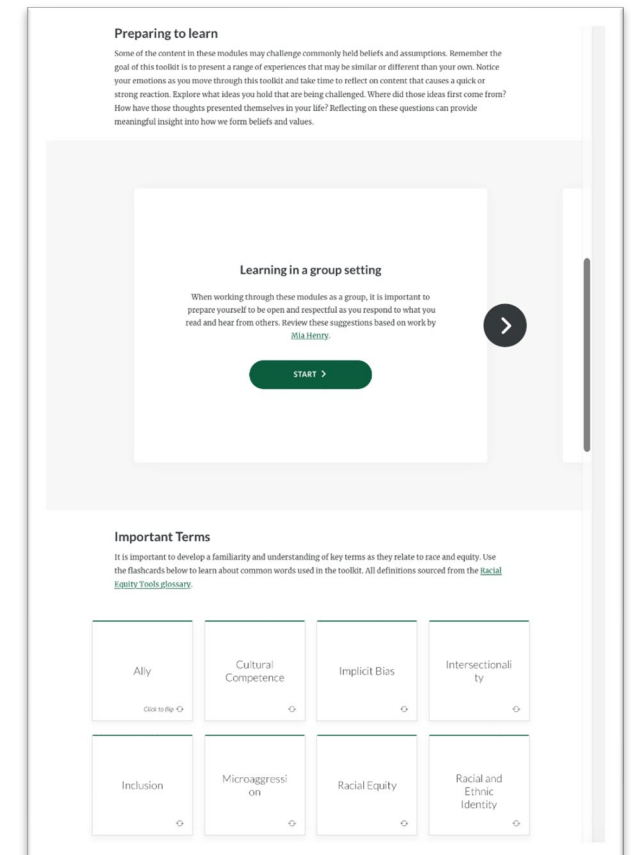
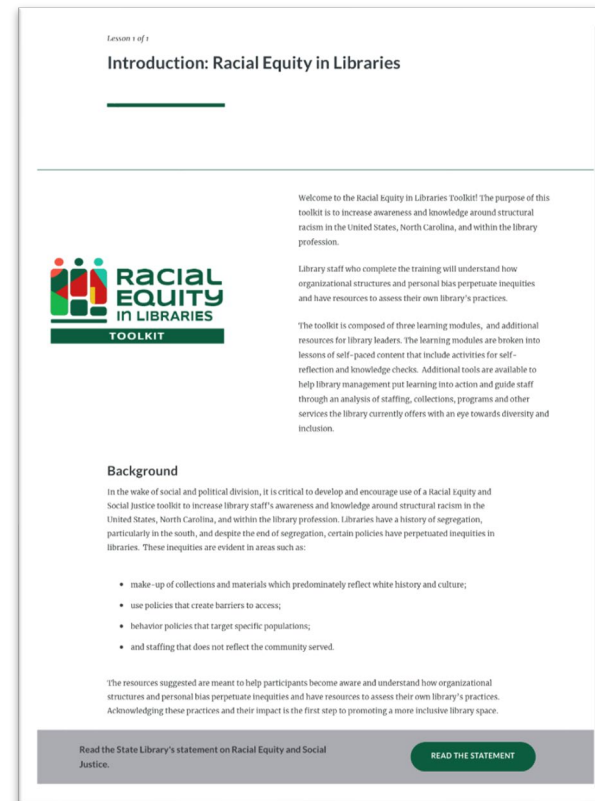

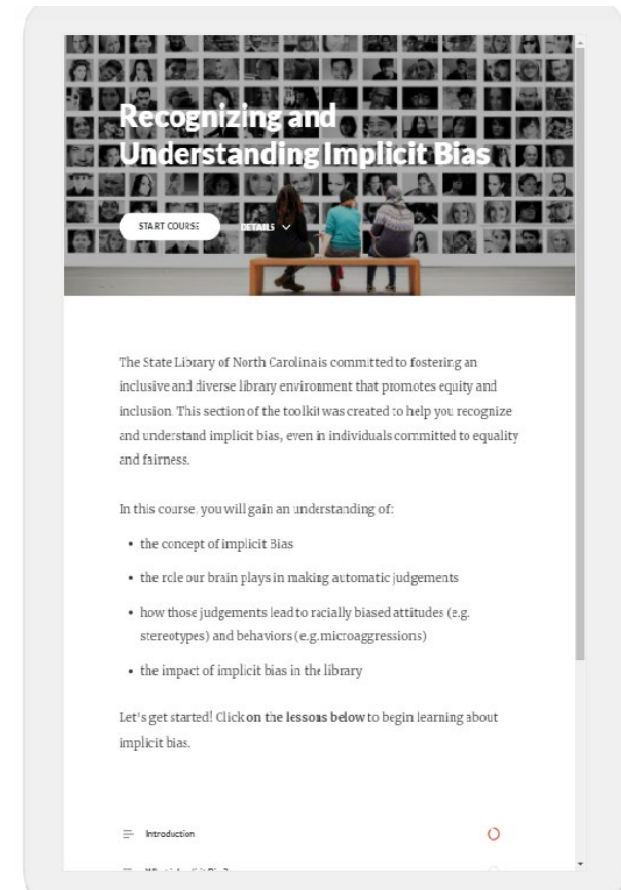

STRUCTURAL RACISM

History of Race and Racism
